
05. The properties shall vest in the Trust.



All the funds of the Trust and the income arising from the investments of the Trust funds shall be applied for the purpose of the Trust in such manner as the Trustees shall from time to time decide at their meetings in accordance with the objects of the Trust. No part of funds or the income shall be utilised for the benefit of any of the Trustees.


10. The Managing Trustee or any one the other Trustees shall have the power:

f) The Trustees shall be entitled to accept deposits and/or obtain loans and to invest the Trust monies either with banks or in other Institutions. Provided always that the Trustees, while investing funds of the Trust, SHALL NOT violate the provisions of the Income Tax Act, 1961 under section 11 and 13 of the said Act as is framed now, subject to such modifications, amendments or alterations to the Act that may be made in future.


Provided further that no clause above said shall be construed as to permit the Trustees to violate the provisions of section 11, 12, and 13 of the Income Tax Act, 1961.

11. The Trustees shall keep a true and correct account of all the Trust monies and the disbursements thereof and the accounts shall be made upto the end of 31st March each year.
12. For any reason the Trustees feel that they cannot carry on the objects of the Trust themselves their the entire corpus of the Trust shall be donated with its obligations and liabilities to any other Trust or Charitable institutions having similar objects and the decision of the Trustees in this respect shall be final.
13. Proper books of accounts shall be maintained regularly and the same shall be audited by a Qualified Chartered Accountant every year.
14. The Income and the funds of the Trust will be solely utilised towards the objects of the Trust and no portion of it will be utilised for payment to Trustees by way of Profit, interest, dividends etc.,
15. In the event of dissolution or winding up of or termination of the Trust, the assets of the Trust shall be handed over or transferred to any other approved Trust or Charitable institutions having similar objects and the decision of the Trustees in this respect shall be final.
16. Any amendment to the Trust Deed will be carried out only with the approval of the Commissioner of Income Tax having jurisdiction over the Trust.
17. The benefits of this Trust are open to all people irrespective of caste, religion, sex etc.,

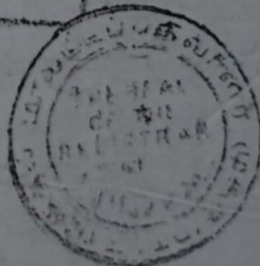

Whereas the Trustees have decided to make certain amendments in the Trust Deed dated 11.11.1998 with regard to the appointment of Managing Trustee, operation of the bank accounts of the Trust etc.,

And whereas the Trustees have thought it expedient to reduce to writing the amendment.

NOW THIS DEED WITNESSETH AS UNDER:

Clause No.9 of the Trust Deed dated 11.11.1998 shall stand altered as under on and from 25.11.2020 The day to day conduct and management of the affairs of the Trust shall be carried on by M.Vignesh who shall hereafter be known as the Managing Trustee. He shall be the Managing Trustee till his life time or as long as he decides to continue as Managing Trustee.

Clause 10(d) of the Trust Deed dated 11.11.1998 shall stand altered as under on and from 25.11.2020 The Managing Trustee M.Vignesh, shall hereafter has the power to open bank accounts in the name of the Trust and the existing bank accounts and new bank accounts which may be opened in the name of the Trust shall be operated by him singly.

To facilitate electronic transfer of funds from the Trust for making payments for and behalf of the Trust, it seems convenient to open bank accounts and credit cards in the individual name of the Trustee. In such cases, such bank accounts may be opened in the name of M.Vignesh, the Managing Trustee by passing a resolution authorizing the Managing Trustee to open the bank account in his name. Separate resolution shall be passed in respect of each such bank account. No personal transactions shall be undertaken through such accounts and credit cards. Such bank accounts and credit cards shall be for the exclusive use of the Trust only.

In all other matters, the clauses in the Trust Deed dated 11.11.1998 shall remain same credit cards except in so far as the same is modified by this Deed continue in full force and effect.
